An exceptionally well balanced property on sought-after street of grand, Grade II listed white stucco villas

Entering on the ground floor, the eye is drawn through to the reception room. With ceilings nearing four meters and a broad bay window framing the building's communal garden, this generous space further benefits from a mezzanine level.

There is a pleasing symmetry found with the bedroom, offering the same grand proportions as the reception space, as well as built in storage. The kitchen & bathroom are found between the two primary rooms.

The Neighbourhood CLOSE

The flat benefits from access to a superb, and substantial, communal garden. Beautifully maintained, and laid out across the gardens of three former townhouses, it is a welcoming and varied space.

The flat is part of a double-fronted stucco townhouse built in the mid-Victorian era. Early residents of the street included aristocrats and statesmen, as well as prominent engineers, politicians and lawyers.

From here, Holland Park underground station is a few moments' walk away, while the restaurants and shops of Notting Hill are also nearby. In addition, the open spaces of Holland Park are close.
